# St. Mark's Forever Fund- What legacy will you leave?



# What is it?

The Forever Fund is an endowment that was established to support the outreach ministry of St. Mark's Episcopal Church. The purpose is to enable St. Mark's to more completely fulfill it's mission by developing outreach ministries beyond what is possible through its annual operating funds. Therefore, distributions from the proceeds of this fund will be primarily for outreach purposes in our community.

The St. Mark's Forever Fund was established as an Endowment Fund in 2015 by the Vestry of St. Mark's Episcopal Church in San Marcos, TX.

In 2016, an Endowment Board was created to provide oversight and management of the Fund, while providing recommendations to the Vestry. This Board is also tasked to provide a liaison to the Episcopal Church Foundation in West Texas where the fund is invested.

The Forever Fund has established guidelines for the investment of funds, the acceptance of gifts and the distribution of proceeds from the fund. These guidelines have been recommended by the Endowment Board and approved by the Vestry and are available for review by request. These guidelines assure donors and potential donors that St. Mark's will exercise good stewardship of all gifts to the fund.

# Who should support it?

The Forever Fund provides a unique opportunity for every single person, young and old, to make an impact on the outreach mission of St. Mark's Episcopal Church. Every contribution, however large or small, will be considered as part of the corpus, principle or basis of the fund.

The Forever Fund is one of the most lasting ways to support the present and future outreach goals of St. Mark's.

Permanent records are kept with the names of all who have been honored by contributions, as a "Tribute to" or "In Memoriam of." A permanent record is also kept of all who contribute to the fund. This is a "Forever" record of every person who contributed to this endeavor.



How Can I Support It?

There are many ways to support the St. Mark's Forever Fund. The most direct and simple way to contribute to the fund is to give cash or a check specifically designated to the "St. Mark's Forever Fund." This can be contributed as a general gift from yourself, or as a "gift in honor of" or gift "in memoriam for" the person of your choosing. These should be clearly marked on your check or envelope containing cash, along with the name of the person to be honored or memorialized.

Other ways to contribute to the fund may require advice or input from a Financial Planner and/or Attorney. Those are:

- Property
- Stocks or Bonds
- Estate (Will)
- Insurance Policy

Members of the St. Mark's Endowment Board are available to discuss the options and benefits but cannot provide legal advice to you.

Types of Contributions include the following:

### Tribute Contributions-

A contribution that is "in honor" of a person or persons, or family.

### Memorial Contributions-

A contribution that is "in memory" of a person or persons, or family.

## Legacy Contributions-

A contribution that is made after the death of the giver. Please see your Attorney or Financial Planner before committing to this

# How does the Forever Fund Endowment work?

All contributions made to the Forever Fund become part of the principal, basis or "corpus" of the fund. Only the interest or investment growth derived from the fund's basis can be distributed for outreach ministry, leaving the corpus or capital intact forever...thus guaranteeing your legacy now and forever.
